Upcoming Regional

The minutes from the Region 4 President's Meeting were distributed and discussed. The following are some items that were listed in the minutes from that meeting:

The Region 4 Host Clubs will not be providing fuel. For our indoor event we will use the Speedway at I-71 & Weber Road as our designated fuel station.

There is a new procedure for safety check. Each car will receive a comprehensive safety check at the first race and receive a Region 4 Safety Sticker to place on the car. That car would then not be required to have a safety check done at subsequent regional events. However, there will be spot checks performed throughout the series.

The fees for our regional races went up to \$30 per car.

There was a lot of discussion of whether we will be enforcing the new rule changes that came from the national meeting. There will be a conference call with the Region 4 Board at a later date and they will let us know which rule changes they are enforcing for our regional race.

Dale Hall will need all available members to help park on Friday morning from 8:30 - 9:30 am and then later in the afternoon.
